Dear Wedding Inquirers,

Thank you for showing interest in our wedding services for all your day of beauty needs. Please carefully review and sign our bridal contract below, and feel free to reach out to us with any questions you may have!

DEPOSIT POLICY: We received many inquiries each year and dates do fill up quickly. Therefore, we require the following to book your dates:

- \$200.00 NON-REFUNDABLE DEPOSIT
- Bridal contract (*Completed & signed*)

Please note your \$200.00 non-refundable deposit will go towards your service total.

To make a deposit you can:

- 1) Send us a check payable to "Blu Skies Salon" and mail to "Blu Skies Salon 440 South Campbell Ave Springfield, Missouri 65806 ATTN: BRIDAL CONTRACT".
- 2) Stop by in person with your signed contract and deposit.
- 3) Make a deposit over the phone using a credit/debit card.

PAYMENT POLICY: Payments are due on the day of service. We accept the following payment methods for services:

- Cash
- Checks (*Please make checks payable to "Blu Skies Salon"*)
- Debit/Credit Cards (*You may pay on-location with a debit/credit card*)

TRAVEL & FEES: Local Travel Fee: \$50 (*Inside Springfield, Missouri Limits*). Travel fees to outside city limits are determined by distance from our salon address (*440 South Campbell Ave Springfield, Missouri 65806*) to the location and back where services are rendered at \$1.50 per mile **both ways**. Any parking, garage or transportation fees will be added to your total and will be due on the day of service. Hotel accommodations may be required for any on- location bookings. In the event we require a hotel accommodation, a 3 or more-star rated hotel would be acceptable within 20 miles where services will be rendered on-location. Hotels must be booked along with this signed contract and non-refundable deposit to reserve your date. An additional stylist fee of \$25 will be added per stylist for parties needing the services of more than one stylist.

CANCELLATION/ADD-ON POLICY: Our stylists work by appointments only. Depending on how many services are needed on your wedding day, determines how many stylists we book out. We ask that if there are any changes to services (*Either cancellations or add-on services*) please let us know as soon as possible.

- In the event a wedding is canceled 30 days or more from the date of the wedding, you will not be liable for any outstanding services due; though you will forfeit the \$200.00 NON-REFUNDABLE DEPOSIT you made to hold your date.

-If there are any cancellations within 30 days of the wedding date, you will be liable for half of the cost for each services canceled. If you cancel a service within 7 days of the wedding date, you will be liable for the full cost of services canceled.

-If there are any add-on services within 30 days to the wedding date, you may request them just keep in mind we may not have time or enough stylists to accommodate these changes but will gladly try to make them work as a last-minute priority if time is allotted.
